1st Session:

Achievements & Challenges (2017 to date):

The first session was presented by explaining the progress and challenges during the period of Oct/2017- Aug/2018. Considering the importance and implementation of the Reform Strategy, MoMP's leadership focused to align the annual work plan based on objectives and interventions defined and described in the reform strategy document. Progress and challenges on the five pillars were presented.

2nd Session:

Contract Management and Compliance

The Contract Management and Compliance presentation focused on the current matters of active contracts, such as Amu Darya and Afghan Tajik. The explanation was taken forward by focusing on ways forward and the anticipated constraints. In addition, the pending and new tender contracts were also discussed.

The below main points were also discussed:

- Ministry's approach to ensure the comprehensive legal regime and policy framework.
- Prioritization and identification of the required donor support based on the MoMP prioritized needs
- Ministry's approach for enhanced private sector engagement through providing an enabling environment.
- Gaps within directorates and the expertise required at different levels- Ministry's approach and vision for capacity building.
- Reform Strategy and capturing production and revenue collection data.
- Implementation of the cadastral (MCAS) and Non-Tax Revenue System (NTRS) and collection of debt from the companies.
- Ministry's conducted value chain studies for different commodities.
- A brief discussion on Zarkashan project.
- Encouraging and guiding investors for more investment in mining sector.
- Capacity building of Afghanistan Geological Survey (AGS).
- Bidding processes and addressing all funding issues.
