The Government of the Islamic Republic of Afghanistan, through the Ministry of Mines and Petroleum (the “Ministry”), has announced a Request for Expressions of Interest dated (17<sup>th</sup> April 2018) the opening of tender processes for:

1. Exploration, assessment and exploitation of quarry materials to be used for the production of cement and/or calcareous binder;
2. Design, construction, financing and operation of a new cement and/or calcareous binder production facility with a minimum production capacity of 0.5 to 1 million tons per annum (subject to phases) of cement and/or calcareous binder,
3. Transformation of such quarry materials into cement and/or calcareous binder and the sale of such cement and/or calcareous binder;
